be on a conference call starting at 0700 and at night at 2000 hrs every day. SFC Flores stated to me that he was having to leave his house by 0400 hrs and not get back home until 2300 hrs. Any Problems he had at home were escalated due to this schedule. SFC Flores had talked with me several times the whole week leading up to the evening of 8 August 2008. He was still upset about the way he was treated at the Scar and was were out from the extremely long hours. I had spoke with SFC Flores around 2015 hrs on 8 Aug 08, he gave no impression to me at that time that he was angry or suicidal we had laughed and joked and spoke about talking in the morning with him. I was in the conf call on 9 Aug 08 SFC Flores wasnt on it I started to call him thinking he just over slept. I found out that he killed himself around 1100 hrs. That evening the company gathered at the CLT when everyone was released myself,
