In the matter of the death of SFC Larry G. Flores. I was interviewed as to the extent of my relationship with him and the events surrounding his suicide. I have known SFC Flores since October 2007 at which time he assumed position of station commander of (b)(6) RS. I maintained a personal and professional relationship with him being friends with his family and known at his home.

To my knowledge he had been having problems at work prior to his death. He had been under threat of relief from his position for about 2 months prior to his suicide. He was not vocal at work about this but did confide in some of his closer friends, myself included. He said he was going to be relieved due to us not being able to make

I waited for him after everybody was released at about 1900. He was an emotional wreck. He told me (b)(6) saved his career by getting him reassigned to (b)(6) KS. I told him I would go with him if he wanted me to. He said he did and he would talk to him about it. I asked him to go to dinner with the rest of the guys from (b)(6) Co. but he said he didn't want to see anybody or talk to anybody but his wife. Then he went home.

He called me Sunday to let me know he was feeling better and make sure I was at work at 0630 on Monday for conference calls with (b)(6). Monday he was a different person. He was quiet and slow. Monday night we didn't go home until 2130 and then he was sad when he left.

(b)(6) I told him to hang in and work it out and things would get better. He seemed to agree but Wednesday he looked worse. In fact Wednesday his wife got in an argument with me on the phone when she called during the conference call and then (b)(6)

(b)(6) On Thursday night he took me outside to talk to me about 2030. (b)(6)

(b)(6) He told me he hated it here now and he didn't even have (b)(6)

(b)(6) I told him to just hang in there and we'd be in (b)(6) in 90 days or less. He kinda perked up for a minute and agreed. Then he told me that he wanted me to know that he appreciated me going to bat for him at battalion and no matter what happened to him not to feel guilty because it showed my loyalty to him and that he didn't know another person in USAFEC that would have done the same. That was the last significant conversation I had with him before he took his own life.
