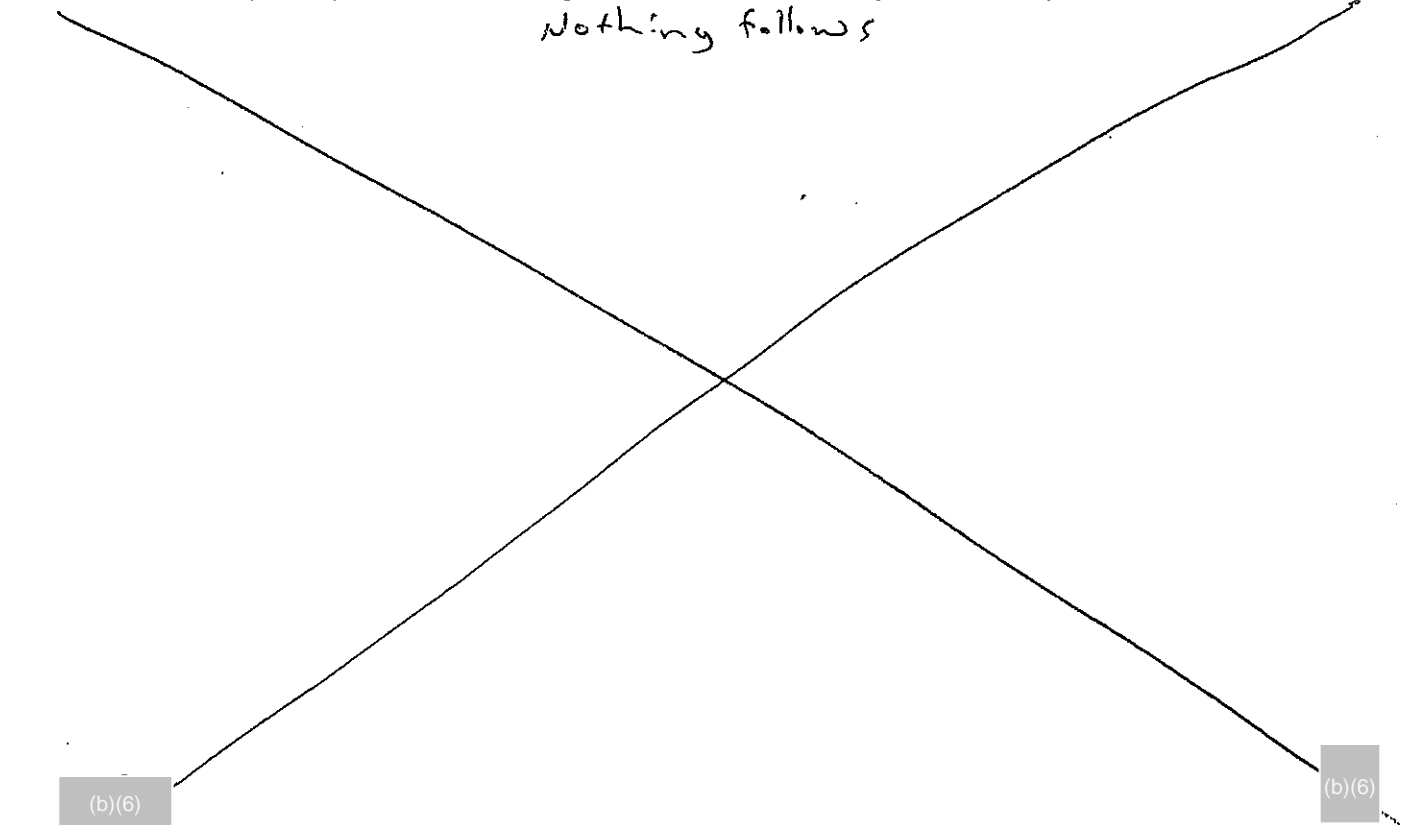

9. I, (b)(6), WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

I worked with SFC Flores over the last year. He was always upbeat and cared for those with whom he served. Upon occasion SFC Flores spoke with me about problems he was having in his professional life. When he was bothered by something it always boiled down to work rather than his personal life. He said he was constantly being threatened to be relieved as station commander of (b)(6). The reason he gave to me was not making mission. I do not know the ultimate source of this pressure. He did tell me that he wanted to be transferred to AMED. He also told me that (b)(6) did not appear supportive of his request but would not tell me why he said that.

(b)(6), (b)(7)b He over looked details of his position that in the past he would not, simple things like approving prospecting plans, being proactive in Future Soldier (FS) programs of the recruiters. SFC Flores would remind us a day in advance that FS next action date was the following duty day. The purpose of this was to make sure the detail recruiter did not make his next action date on a non duty day such as a Sunday as an over site. So in my opinion something that happened that day changed SFC Flores. It is my believe that the undue stress from his job as Station Commander of (b)(6) drove SFC Flores to the point that he wanted to take his own life. While stress from his family life may have been a contributing factor I hold that stress from his job made his family life what it was.
