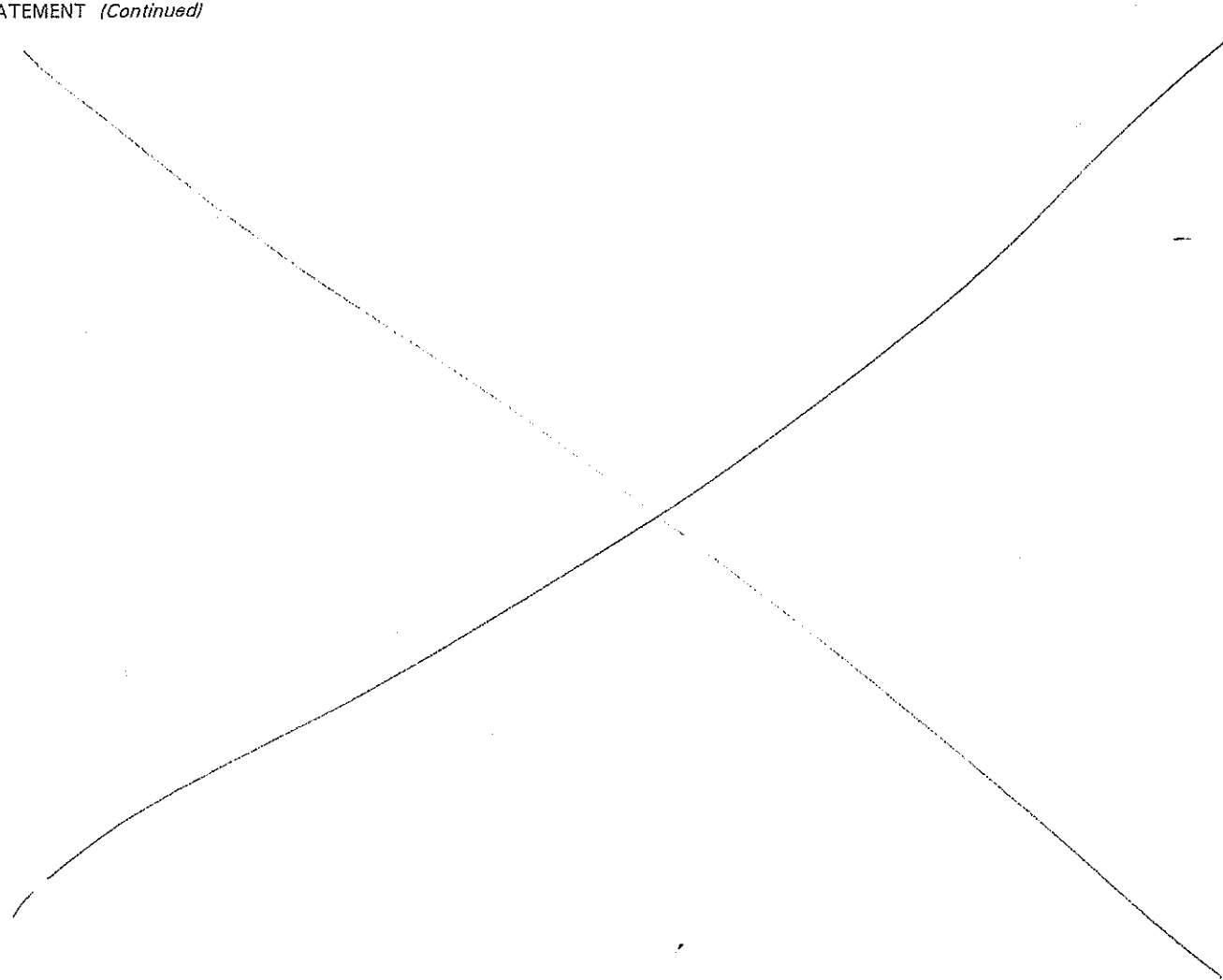
I, (b)(6), WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

Before taking possession of the fire arms I ensured they were all empty which they all were. On 20070306 was to end is when I received the call that I had lost my friend.

(b)(3), (b)(6) He was always extremely stressed out about work, because no matter how hard he was going to Zero roller training and having to write essays. He told us all he wanted to do was go back to the regular army because this job wasn't for him. He loved the army, but stated that recruiting had changed his mind about staying in and that he wanted just to go back to Oregon. (b)(6) was at our station and I told him that SGT Andersson wasn't cut out for this job and he stated that it was just a lack of training. The week prior to his suicide, SGT Andersson had to write three different essays for failing to have a tester for the week. On Monday March 5th, he was scheduled his (b)(3) the appt went. He stated that they (b)(3) I was the only one in the office when he came in around 1300 and I asked him how informed me that he and Cassie had gotten married that morning. (b)(3) but that the appt had gone well. Then he (b)(6) That night, before leaving, he played a prank on the Station Commander that made everyone laugh. It was a complete shock the next morning when I got the phone call. He had his rough days and he also had his days where he came in happy and would act goofy. As an office, we all reached out to him and tried to support him. When something like this happens, you always feel like you should have done more. End of Statement
