DESCRIPTION OF ITEMS

Scope of work – XSAPI weight reduction prototype contract

Description of item:

- (1) 300 XSAPI samples with ESAPI weight. 50 samples for each size (XS, S, M, L and XL). Incremental delivery (min 50 samples per design, sizes are evenly distributed) is acceptable. One or more (up to 5) different designs are allowed for delivery. The following information is required for each delivery:
  - a. Tile type
  - b. Tile thickness (nominal, max and min)
  - c. Backing type
  - d. All components used and break down to areal density
  
- (2) 50 ceramic tiles. The tiles must be the same as used in XSAPI samples. Incremental delivery (min 10 samples per design, sizes are evenly distributed) is acceptable.
