

SUBJECT: Beret Flash and Background Trimming for D Company, 3d Squadron, 16th Cavalry Regiment

1. In accordance with the provisions of AR-670-1, a beret flash and background trimming are authorized for wear by members of D Company, 3d Squadron, 16th Cavalry Regiment.
2. The descriptions of the designs are as follows:

BERET FLASH

A black shield-shaped embroidered item with a semi-circular base 2 1/4 inches (5.72 cm) in height and 1 7/8 inches (4.76 cm) in width overall, divided diagonally by a golden yellow stripe from upper right to lower left, surmounted by a narrow orange stripe, edged with a 1/16 inch (.16 cm) white inner border and 1/8 inch (.32 cm) scarlet outer border, marked with six scarlet hash marks three to the left and three to the right.

BACKGROUND TRIMMING

A black oval-shaped embroidered item 1 3/8 inches (3.49 cm) in height and 2 1/4 inches (5.72 cm) in width overall, divided diagonally by a golden yellow stripe from upper right to lower left, surmounted by a narrow orange stripe, edged with a 1/16 inch (.16 cm) white inner border and 1/8 inch (.32 cm) scarlet outer border, marked with six scarlet hash marks three to the left and three to the right.

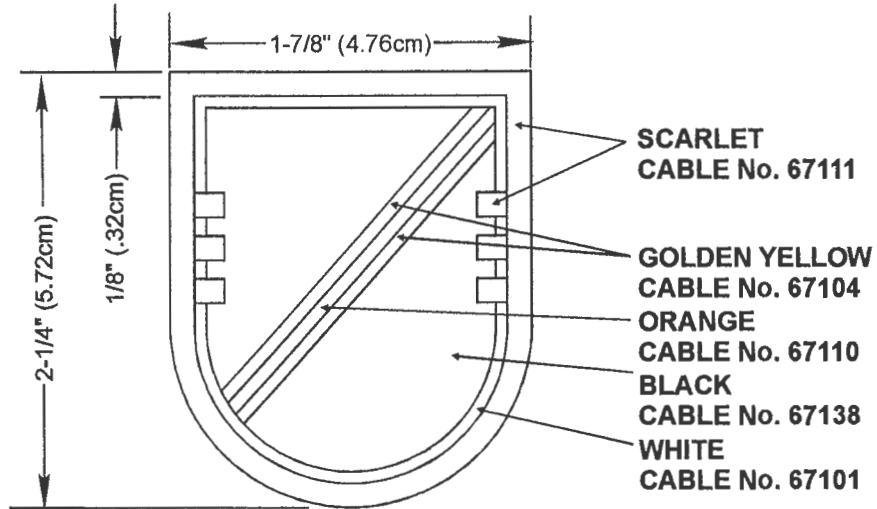



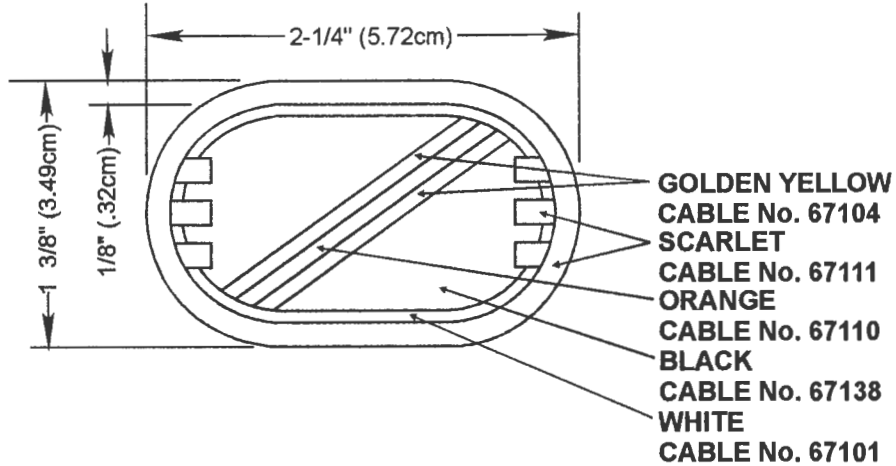
