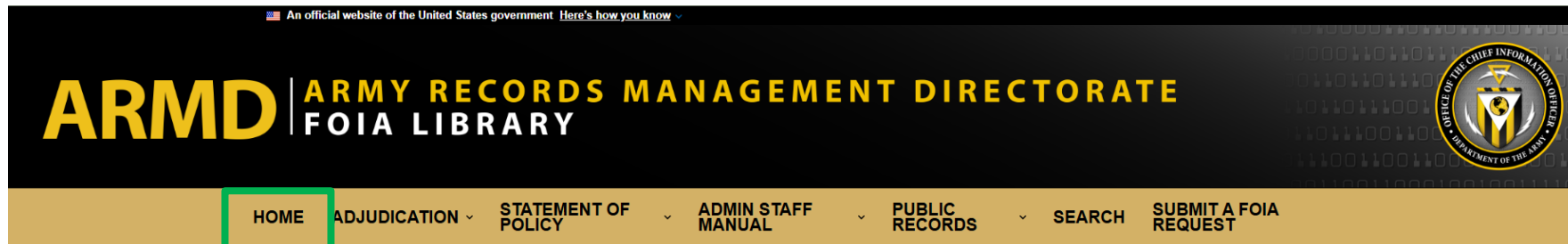

WELCOME TO THE ARMY'S FREEDOM OF INFORMATION ACT LIBRARY

The Electronic FOIA Amendments of 1996 (often referred to as e-FOIA) was signed into law to "bring the FOIA into the electronic age." The legislation requires that agency records that have been released in response to FOIA, or that may become the subject of subsequent FOIA requests, be made publicly available. As a result, most agencies developed FOIA Libraries to make the documents more accessible to the public.

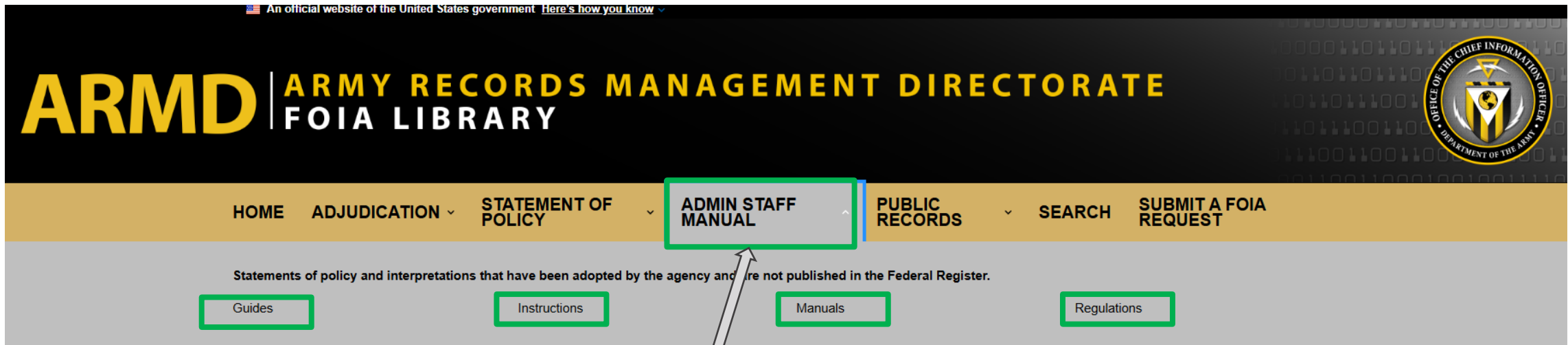

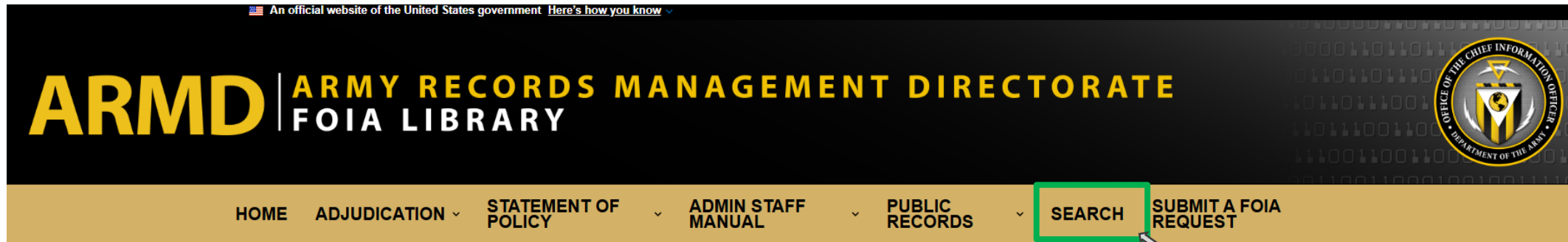
